ICD FOUNDATION DONATES TO SINDECUSE **MUSEUM OF DENTISTRY**

The ICD Foundation recently gifted the Sindecuse Museum \$3,000 for helping save and promote the ICD video collection, "Outstanding Leaders in Dentistry". The museum staff was able to catalog the videos in the museum online database and include YouTube access. This required the help of IT staff, collection coordinators, and a history student who compiled biographical details.

The deadline for new candidates is May 15th...with all forms completed and submitted to national. That makes May 5th our effective deadline to sponsor someone, leaving us enough time to have our nomination committee vet the candidate and have the secondary sponsor letter submitted.
